
Highlights of the May Tech Seminar

PAINT AND BODY





About 16 members made it through the foggy morning and assembled to hear a real professional talk about a long involved process on what it takes to prep a car for painting.

Dave Knapp started with a little history in the evolution of paints and quality though the present day - changed mainly due to the environmental concerns and state laws enacted. Primers have changed and Dave emphasized that buying a quality primer even though the cost is higher will be the best in the long run.

Speaking of cost! Labor and materials have gone insane in the past 10 years.


(I had a estimate done on my Honda - it was more than the car's worth!).

Dave covered the process in fixing a dent, finding holes in metal and how to get inside for rust and how to conquer that in the right way. Materials for safety and for use in the paint prepping process - respirator is very, very important. Paint tools were also discussed: sanding blocks, sandpaper and spray gun nozzle patterns.

I want to thank Dave for educating us on the basics of what it takes to prepare for paint.

OCMAFC Military Veterans

Steve Pavich USAF 1964-1968

I was given my first car from my uncle Henry when I was twelve years old. It was a 1930 Chevy Coupe and since I was unable to get a drivers license, I drove it in my father's back yard in West Los Angeles until it literally fell apart. From age thirteen to sixteen I owned a 1937 Nash, a 1952 Ford station wagon and a 1950 Ford V-8 Coupe that I acquired for \$50.00. I drove the



coupe to Tijuana and had tuck and roll upholstery installed and had it painted silver-blue. Twelve months later, I traded it for a 1940 Ford Coupe powered by a 1955 Oldsmobile 455 V-8 with a Lincoln Zephyr three speed transmission. The '40 Ford was the fastest car at my high school. Not counting RV's, ATV's, boats, trailers and motorcycles, I've owned some 130 cars and only one of those was purchased brand new. I've restored and sold thirty-four vintage Mustangs (1965 - 1969) and six Model A's.

I graduated from St. Bernards High School, Playa-del-Rey in 1964 and had no real plans for college so like my cousin Mike had done a year before me, I joined the US Air Force. My enlistment lasted four years and after boot camp at Lackland AFB, I was sent to Carswell AFB in Fort Worth, Texas. During that three year period, I spent time in Alaska, England, Scotland and France working on the flightlines repairing aircraft, providing equipment and ground power and moving aircraft. While at Carswell AFB I was also assigned to the base motor pool where I learned mechanical skills working on military vehicles. The military experience was exactly what I needed and fortunately, I had decided to attend Santa Monica City College upon leaving the military. The decision to attend college probably saved my life because the Air Force asked me to extend my tour and be sent to Vietnam as a sniper due to my expert marksmanship. After two years at the JC, I attended Long Beach State College followed by two more years at Pepperdine University earning a Masters Degree in Education.

In 1970 I married the love of my life for 54 years, Debbie. Actually, my father was responsible for me meeting my future wife as she had recently moved from Chicago to Santa Monica working as a medical technologist in a lab in the medical building where my Dad went for check ups. My first teaching job (1970) was at Lincoln Middle School in Corona del Mar teaching 8th Grade US History and serving as the school's Activity Director. Ten years later, I accepted a job at Newport Harbor HS where I was a full-time Activities Director and later became a Vice Principal and Principal. I retired from the Newport-Mesa School District in 2000, joined the OC Mustang Club and later the OC Model A Club. I have two wonderful children and two great grandchildren who live within walking distance of my home in Fountain Valley.

My military experience proved to be a valuable learning experience. I'd like to see the US adopt the Israeli requirement where young men and women serve in the military or other community service. I'm blessed to have learned respect and pride for my country through my parents and my military experience.

With heavy hearts and profound sadness, we announce the passing of Arthur Clifton Moore, 80, of Upland CA. He was a much loved husband, father, grandfather, great-grandfather, uncle, cousin and friend. Art left this world peacefully surrounded by the love of his family by taking God's hand on August 22, 2024.

Art was born in Maxwell, Nebraska on April 27, 1944 to the late Clifton and Ethel Moore. Art Leaves behind his wife, Olive, of 40 years, his children, Kevin Moore, Kristina Sim-

mons, Kelly Moore, Syndee (Tony) Davis and Melita (Steve) Crowell, and a sizable group of grandchildren and great-grand children.

Art grew up on a small farm near Gothenburg, Nebraska. He attended a small elementary country school, but drove into town for high school. He especially enjoyed his welding class in his senior year, which was the beginning of his lifelong career as a welder and successful owner of Claremont Welding in Montclair, California for over fifty years.

Having grown up on a farm, Art learned to work hard. Besides working long, hard hours as a welder, Art pursued being a private aircraft pilot. Through the next few years, he purchased and restored airplanes that were damaged and needed to be rebuilt. He also had a passion for Model A Fords. He had a Tudor Sedan while still in high school, and once in California, he would buy parts and pieces at swap meets, built chassis and sell them, using the money to buy more parts and pieces.

Unfortunately, in 1981 at the age of 37, Art was on his way back from a worldwide air show in the Midwest and crashed in his airplane do to bad weather and instrument failure, resulting in a spinal cord injury that left him a paraplegic.

Art had always been know for his persistence and determination and he was determined to succeed even in a wheelchair...and he did!

Three years after his accident, Art met Olive at church. They dated over the summer of 84 and married in September. It was definitely a match made in heaven! Olive enjoyed flying and being involved with Art in the car clubs. He was a member of the Santa Anita A's, Orange County Model A Ford Club, Four Ever Four Club and the Model A Touring Club.

All that knew Art would agree that he lived his life to the fullest. He found pleasure in rebuilding Model A's, and even racing a Speedster that he had built, often taking Ist place in competitions. Art enjoyed helping fellow car enthusiasts work on their cars and sharing his knowledge and experience.

Art had a strong faith in God. Art and Olive attended Hillside Community Church and he especially enjoyed participating in the Generations Bible Class. He always gave God credit for helping him through tough times and for his accomplishments.

Everyone loved Art. He has left a lasting impression on everyone who had the privilege of knowing him. His boundless energy inspired so many to accomplish things they had set aside or projects they were hesitant to tackle. May his memory live on in the hearts of those he touched. Route 66 – or 62, or 60, or ???

The drama over numbering the new highway-to-be had three main characters: Cyrus Avery, Frank Sheets, chief highway engineer for Illinois and B. H. Piepmeier, chief highway engineer for Missouri. They agreed that the new highway should carry the number 60. But officials from Virginia and Kentucky thought the new highway should end in Newport News, Virginia, splitting in Springfield, Missouri and the split going to Chicago should be 60-North.

Avery was so confident of his position that he and Piepmeier ordered highway signs for Oklahoma and Missouri marked as U.S. 60. Missouri also printed 600,000 road maps showing Highway 60 going through the state from Joplin to St Louis.

This caused so much controversy that Thomas H. MacDonald, chief of the Bureau of Public Roads, warned Avery that congressional involvement might lead to a legislative attempt to defeat the whole plan for a national highway system! MacDonald thought too much was being made of this whole issue of numbering and routing anyway. He wrote, "I do not feel that it makes one bit of difference to the States along the route from Chicago to Los Angeles whether it is Route No. 60 or 62 or any other number..."

Was the whole plan going to go down the drain?




